

(1) To delete existing street parking places and waiting restrictions and substitute (a) and (b) below.

(a) *Residents Parking Places*

Church Square, south side, between a point 41 metres west of its junction with Church Street and a point 14 metres west of that point.

Church Square, south side, between a point 111 metres west of its junction with Church Street and a point 18 metres west of that point.

Church Square, north side, between a point 128 metres west of its junction with Church Street and a point 34 metres west of that point.

Church Square, western end, between a point 271 metres west of its junction with Church Street (north side) and a point 5 metres south of that point.

Church Square, western end, between a point 216 metres west of its junction with Church Street (south side) and a point 10 metres north-west of that point.

(b) *No waiting at any time*

Church Square, all sides, for its entire length, except for those lengths specified in (a) above.

(2) To introduce one-day visitors parking permits, which may be issued to any resident of Church Square, free of charge. Permits will be issued by Basingstoke and Deane Borough Council.
