

## TOWN AND COUNTRY PLANNING ACT 1990

The Secretary of State for Transport hereby gives notice that he has made an Order under section 247 of the above Act entitled "The Stopping-Up of Highways (County of Tyne and Wear) (No. 26) Order 1993" authorising the stopping-up of areas of Bathgate Avenue and Beeston Avenue, Town End Farm, Sunderland, to enable the development described in the Schedule to this notice to be carried out in accordance with planning permission granted by Sunderland City Council on 30th September 1992 under ref. 92/1185.
