Chesterfield Borough Council Church Lane (Prohibition of Waiting) Order 1993

Notice is hereby given that the Chesterfield Borough Council pursuant to arrangements made with the Derbyshire County Council under section 101 of the Local Government Act 1972 and in exercise of the powers conferred by sections 1(1), 2(1), 4 and 32 of the Road Traffic Regulation Act 1984 intend to make an Order the effect of which will be:

(1) *No Waiting at Any Time*

Church Lane (north and south sides), from Church Way for its entire length.

(2) To provide parking bays for the sole use of disabled persons' vehicles.

(3) To provide a loading/unloading area for vehicles.

Exemptions will be provided in the Order for disabled persons' vehicles to wait; for emergency service vehicles; to enable vehicles to wait for a person to board or alight from the vehicle; or demolition, the removal of any obstruction to traffic, or the maintenance of the roads or the services therein.

Full details of the proposals are in the draft Order which together with a map showing the prohibited areas may be examined at the Town Hall Reception on any weekday during normal office hours.

Should you wish to object to the proposed Order you should send the grounds of your objection in writing to the undersigned by 16th September 1993.

Chesterfield Borough Council (Off-street) Parking Places Order 1993

Notice is hereby given that the Chesterfield Borough Council in exercise of the powers conferred under section 35 of the Road Traffic Regulation Act 1984 and of all other enabling powers intend to make an Order the effect of which is to introduce two additional off-street parking places. They are:

(1) *Area to the east of the Revenues Hall and to the north of 87 New Square*

This parking area will be for the sole use of "Orange" Badge Holders for up to 3 hours at no charge.

(2) *Area and Access Road to the west of the Revenues Hall, New Square*

This parking area will be designated for permit holders as determined by the Council.

Any other vehicles parking in the above areas will be liable to a standing charge of £20 for parking in contravention to the Order.

Any person wishing to examine the draft Order may do so by calling at the Town Hall Reception on any weekday during normal office hours.

Any objections to the proposal must be submitted in writing to the undersigned so as to arrive no later than 16th September 1993.

CUMBRIA COUNTY COUNCIL

The County of Cumbria (Various Roads, Workington) (Consolidation of Traffic Regulations, Prohibition and Restriction of Waiting and Provision of Street Parking Places) Order 1993.

Notice is hereby given that on 20th August 1993 the County Council of Cumbria made an Order under the Road Traffic Regulation Act 1984.

Full details of the Order, summarised below, and which comes into effect on 1st September 1993, may be inspected at the offices of Allerdale Borough Council, Allerdale House, Workington, and the offices of the undersigned during normal working hours. The details include a copy of the Order, together with a plan, a statement of the County Council's reasons for making the Order, and copies of the Orders to be revoked.

The following is a summary of the traffic regulations. Please refer to the documents on deposit for further details:

(1) Consolidation of existing Traffic Regulations in Workington;
(2) No Waiting at any time in part or parts of the following: Bank Road; Bishop Street; Corporation Road; Dean Street; Derwent Street; Dora Crescent; Elizabeth Street; Ellerbeck Lane; Falcon Place; Harrington Road; Infirmary Road; James Street; Morley Street; North Watt Street; Park End Road; Peter Street; Ramsay Brow (entrance to Magistrates Court); Senhouse Street; Stanbeck Meadows; Upton Street; Victoria Road; Warwick Place and Wybrow Terrace. A short length of "No waiting at any time" restriction to be removed from Belle Isle Street.

(3) Disc Parking Places—Monday to Saturday, 8.30 a.m. until 6 p.m.—waiting limited to 1 hour, return prohibited within 1 hour in part or parts of the following: Corporation Road; Gray Street; John Street; * Lismore Place; Peter Street; Upper Jane Street; * Warwick Place and Wybrow Terrace.

* Residents Only parking to be removed.

(4) Provision of parking places—8.30 a.m. to 6 p.m., Monday to Saturday, in Park Lane and Princess Street.

(5) No Waiting within parking places—8.30 a.m. to 6 p.m., Monday to Saturday, or at any time in part or parts of the following: Gray Street; Murray Road; Park Lane; Peter Street; Roper Street; South William Street and Wybrow Terrace.

(6) No Waiting, Monday to Saturday, 8.30 a.m. to 6 p.m., in part or parts of Ritson Street and Upton Street.

(7) Provision of two Disabled Parking spaces on Brow Top.

(8) No loading or unloading—Monday to Saturday, 8.30 a.m. to 6 p.m., in part or parts of Fearon Place and Upton Street.

(9) The revocation of some existing Traffic Regulation Orders including the Borough of Workington (Traffic Regulation) (No. 1) Order 1967, which revokes an existing 6 feet 6 inches width restriction on Morley Street.

(10) Please note that the Order includes a provision under the Resident's Exemption Scheme that eligible residents will be granted no more than two certificates per premises.

If you wish to question the validity of the Order, or any provision contained in it, on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made thereunder has not been complied with in relation to the Order you may within 6 weeks from 27th August 1993, apply to the High Court for this purpose.

CUMBRIA COUNTY COUNCIL

The County of Cumbria (Fearon Place, Workington) (Loading Bay) Order 1993

Notice is hereby given that on 20th August 1993, Cumbria County Council made an Order under sections 45 and 53 of the Road Traffic Regulation Act 1984.

The Order, which comes into effect on 1st September 1993, will authorise that area of highway at the south-east side of Fearon Place, Workington, from a point 11 metres north-east of its junction with Upton Street to a point 41 metres north-east of its junction with Upton Street, to be used between the hours of 8.30 a.m. and 6 p.m. on any day other than a Sunday, as a parking place for goods vehicles which are loading onto or unloading from that vehicle. The normal exemptions to apply.

A copy of the Order, together with a plan showing the effect of the Order, together with a statement of the Council's reasons for making the Order, may be inspected at Allerdale House, Workington, and at the offices of the undersigned during normal working hours.

If you wish to question the validity of the Order or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made thereunder has not been complied with in relation to the Order, you may within 6 weeks from 27th August 1993, apply to the High Court for this purpose.
