#### KNOWSLEY METROPOLITAN BOROUGH COUNCIL

*Knowsley Metropolitan Borough Council (Trentham Road, Kirkby) (Prohibition of Waiting) (Ambulances only Parking Bay) Order 1993.*

Notice is hereby given that on 27th August 1993, the Council of the Borough of Knowsley in exercise of its powers made an Order under sections 1(1), 2(1) to (3) and 4(2) of the Road Traffic Regulations Act 1984.

2. When this Order comes into effect on 31st August 1993:

- (a) No person(s) will be allowed to cause or permit any vehicle to wait between the hours of 8 a.m. to 6 p.m. Monday to Saturday inclusive on the following lengths of road:
  - (i) *Mercer Avenue*, south side, extending 13.7 metres both sides of its junction with *Trentham Road*;
  - (ii) *Trentham Road*, north-west side, extending 13.7 metres south from its junction with *Mercer Avenue*; and
  - (iii) *Trentham Road*, north-east side, extending from its junction with *Mercer Avenue* in a south-easterly direction for 69 metres; and
- (b) that part of the highway situated along the southerly side of *Trentham Road*, *Kirkby*, extending from a point 38 metres south of its junction with *Mercer Avenue* in a southerly direction for 6 metres, as shown on plan No. TES/TM/764 is authorised to be used as an Ambulance Parking Bay.
