TOWN AND COUNTRY PLANNING ACT 1990

Stopping-up of a Highway at Bury, Greater Manchester

The Secretary of State for Transport hereby gives notice that on the application of Jenkins Technical Services Limited on behalf of Koverall Limited he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of a length of Back Heywood Street West, Bury, from a point 5 metres north-east of its junction with Parker Street to its junction with Mason Street.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Koverall Limited by Bury Metropolitan Borough Council on 10th August 1993 under reference 28709/93.

Copies of the draft Order and relevant plan may be inspected at all reasonable hours during the 28 days commencing on 30th November 1993 at the offices of the Bury Metropolitan Borough Council, Town Hall, Knowsley Street, Bury, and may be obtained free of charge from the Department of Transport (quoting reference TNW 5081/35/1/24) at the address stated below.
