Notice of the Issue of a Submarine Pipe-Line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, a works authorisation to be held by Hamilton Oil Company Ltd., whose address is Wimbledon Bridge House, 1 Hartfield Road, Wimbledon, London SW19 3RU, for the construction of a 12 inch pipe-line, a 2 inch piggy-backed pipe-line and two ½ inch corrosion inhibitor

umbilicals between the Johnston Subsea Facility and the Ravenspurn North Platform.

Except with the consent of the Secretary of State, the 12 inch pipe-line shall only be used to convey hydrocarbon gas, the 2 inch pipe-line shall only be used to convey methanol and the two ½ inch pipe-lines shall only be used to convey corrosion inhibitors.

The pipe-lines may be used by the holder and with the holder's agreement, and with the consent of the Secretary of State, by other persons.

Hamilton Oil Company Ltd., has been appointed operator of the pipe-lines.
