The County of Devon (Seventh Street, Barnstaple) (Parking Places) Order 1994

The County of Devon (Plymouth Road/Coypool Road Area, Plympton, Plymouth) (Prohibition of 'U' and Right Turns) Amendment Order 1994.

Notice is hereby given that on 9th February 1994, the Devon County Council made an Order under sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.
