The Stopping up of Highways (County of Essex) (No. 1) Order 1994

The Secretary of State for Transport gave notice on 29th January 1993 that, on the application of Essex County Council, he proposed to make an Order under section 247 of the above Act to authorise the stopping up of an area of highway land in Colchester Road, Coggeshall to enable residential development consisting of the erection of one 2-storey detached and three 2-storey terraced residential buildings with garaging, parking spaces, landscaping and a new footpath to be carried out in accordance with planning permission deemed to have been granted under Part III of the said Act.

The Secretary of State for Transport hereby gives notice that he has made the Order under section 247 of the above Act entitled "The Stopping Up of Highways (County of Essex) (No. 1) Order 1994" incorporating a modification which reduces the maximum width of the area to be stopped up from 13 metres to 12 metres.
