(a) to suspend the County Council of Avon (City of Bath) (Outer Area) (General Traffic Regulation) (Consolidation) Order 1988 in so far as it relates to the one-way traffic working on Great Stanhope Street in favour of the restriction specified at item 1(1) above, and

(b) to extend the "no waiting at any time" restriction on the north side of Great Stanhope Street in the vicinity of the cycle lane referred to in item 1(a) above.
