PETROLEUM AND SUBMARINE PIPE-LINES ACT 1975

Notice of the Issue of a Submarine Pipe-line Works Authorisation

The Secretary of State for Trade and Industry hereby gives notice that he has decided to issue, and in consequence has issued, works

authorisations, to be held by Hamilton Oil Company Limited, whose address is Devonshire House, Piccadilly, London W1X 6AQ, for the construction of two 14-inch oil export pipe-lines; two 20-inch, one 16-inch and one 14-inch gas export pipe-lines; one 12-inch gas injection pipe-line; two 3-inch condensate/chemical pipe-lines and four 2-inch chemical injection pipe-lines.

Except with the consent of the Secretary of State, the 14-inch oil export pipe-lines shall only be used to convey crude oil; the 20, 16 and 14 gas export pipe-lines and the 12-inch gas injection pipe-line shall only be used to convey natural gas; the 3-inch condensate/chemical pipe-lines shall only be used to convey condensate and chemicals and the 2-inch chemical injection pipe-lines shall only be used to convey methanol and corrosion inhibitors.

The pipe-lines may be used by the holder and, with the holder's agreement and with the consent of the Secretary of State, by other persons.

Hamilton Oil Company Limited has been appointed operator of the pipe-lines.
