(ii) From a point 110 metres north of its junction with Summerfield Road northwards to the Slip Road leading from Gateshead Highway.

2. Limited Waiting 8 a.m. to 6 p.m. Monday to Saturday (Thirty Minutes in Any One Hour) Durham Road, Low Fell, west side, from a point 129 metres north of its junction with Enfield Road northwards for 19 metres.

Normal exemptions will apply, including those for disabled persons' vehicles.
