GLOUCESTERSHIRE COUNTY COUNCIL

Gloucestershire County Council (Naas Lane and Upton Lane, Brookthorpe) (7.5 Tonne Weight Restriction) Order 1994

Notice is hereby given that on 24th May 1994, the Gloucestershire County Council made an Order under the Road Traffic Regulation Act 1984, the effect of which is to prohibit any goods vehicle whose maximum gross weight exceeds 7.5 tonnes from proceeding in:

- 1. That length of Class III road number 215 known in part as Upton Lane and part as Winny Croft Lane partly within the parish of Brookthorpe with Whaddon (Stroud District) and partly within Gloucester City which extends from its southern junction with the Stroud to Gloucester Road (A4173) in a generally north easterly direction to its junction with Sneedhams Road (unclassified).
- 2. That length of Class IV road number 209 known as Naas Lane partly within the parish of Brookthorpe with Whaddon (Stroud District) and paetly within the parish of Quedgeley (Gloucester City) which extends from its southern junction with the Brookthorpe to Haresfield Road (3/215) in a generally north westerly direction to a point 332 metres south-east of its south-eastern junction with Needham Avenue (unclassified).

Exceptions in the Order will enable vehicles to proceed to gain access to premises and also if in the service of a statutory undertaker or one of the Emergency Services.
