ST. James's, October 10. The following Addresses have been presented to His Majesty.

An humble Address of the Lord-Lieutenant, High-Sheriff, Deputy Lieutenant, Justices of the Peace, and Gentlemen met at the General Quarter Sessions of the Peace held at the Castle of Exon i and for the County of Devon on the 4th Day of October 1715, sent up by Sir William Courtenay, his Majesty's Lieutenant of the said County, and presented to his Majesty by the Right Honourable the Lord Viscount Townshend, one of his Majesty's Principal Secretaries of State.

An humble Address of the Capital Burgesses and other Inhabitants of the Borough of Leominster in the County of Hereford; presented to his Majesty by the Right Honourable the Lord Coningsby, Lord-Lieutenant of the said County.

An humble Address of the Lord-Lieutenant, High-Sheriff, Deputy-Lieutenants, Justices of the Peace, Grand-Jury, Gentlemen and other Freeholders of the County of Berks; presented to his Majesty by his Grace the Duke of St. Albans.

An humble Address of the Mayor and Commonalty of the City of New Sarum; presented to his Majesty by the Right Honourable the Lord Herbert.

An humble Address of the Mayor, Bailiffs, Burgesses and principal Inhabitants of the Town and County of Southampton; presented to his Majesty by their Recorder, introduced by the Right Honourable the Lord Viscount Townshend, one of his Majesty's Principal Secretaries of State.

Which Addresses His Majesty was pleased to receive very graciously.

From the Camp at Stirling, October 4. On the 2d Instant the Rebels detached from Perth about 400 Horse and 500 Foot, to the Sea-Coast of Fyfe, where was a small Vessel near to Bruntisland with some Arms on Board which were designed for the Earl of Sutherland, but the Vessel being detained by contrary Wind, and the Rebels having

Notice of it, they got Boats and boarding the Vessel in the Night, seized and carried off to Perth the said Arms being in Number about 300. His Grace the Duke of Argyle not having had Intelligence of the March of the foresaid Detachment from Perth and of their Design till the 3d in the Morning, both he and the other General Officers were of Opinion, that it was too late to think of intercepting them. That Day his Grace being informed, that the Earl of Mar proposed to be the following Night at Arva 4 Miles from Stirling, with a strong Detachment, he ordered out the Picquets of Horse and Foot, and had all the Troops ready to march to sustain them if there had been Occasion; but none of the Rebels appearing, the Picquets returned to the Camp. His Grace continues encamped here, having with him the Regiments of Foot of Orrery, Shannon, Montague, Grant, Irwin, and Forfar, and the Regiments of Dragoons of Carpenter, Portmore, Stairs, and Kerr, and expects every Day to be joined by Evans's Regiment of Dragoons from Ireland, and also very soon by 4 Battallions of Foot from that Kingdom; which 'tis not doubted will put his Grace into a Condition to give a good Account of the Rebels. The fencible Men of Glasgow and of several of the Western and Southern Shires are part of them in this Camp, and the rest are quartered in this Neighbourhood, ready to join the regular Forces on Occasion.
