#### WELWYN HATFIELD DISTRICT COUNCIL

*The District of Welwyn Hatfield (Longcroft Lane and Birdcroft Road, Welwyn Garden City) (Prohibition of Driving) Order 1994*

Notice is hereby given that the Welwyn Hatfield District Council proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The Order will prohibit motor vehicles from proceeding:

(a) In that length of Longcroft Lane, Welwyn Garden City from a point 83 metres south of the southernmost kerb-line of Birdcroft Road, for a distance of 3.7 metres in a southerly direction.

(b) In that length of Birdcroft Road at its junction with Longcroft Lane, from the western kerb-line of Longcroft Lane for a distance of 8.5 metres in a westerly direction.

The effect of the Order will be to prevent through traffic in Longcroft Lane and to prohibit vehicles from turning into or out of Birdcroft Road at its junction with Longcroft Lane.

Exemptions will apply to emergency service vehicles, vehicles engaged in maintenance or statutory duties and to pedal cycles.
