## TOWN AND COUNTRY PLANNING ACT 1990

*Stopping-up of Highways at Winsford*

The Secretary of State for Transport hereby gives notice that on the application of Vale Royal Borough Council on behalf of Wilcon Homes Northern Limited he has made an Order under section 247 of the above Act entitled "The Stopping-up of Highways (Borough of Vale Royal) (No. 1) Order 1994" authorising the stopping-up of a length of Deakins Road, at Wharton Green, Winsford and requiring the provision of a new highway.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the above Act or that any requirement of that Act or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 6th July 1994, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

## HIGHWAYS ACT 1980

*The (A50) Nottingham-Derby-Stoke-on-Trent Trunk Road (Blythe Bridge to Queensway and Connecting Roads) (Side Roads) Variation Order 199*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 14, 125 and 326 of the Highways Act 1980 providing that the A50 Nottingham-Derby-Stoke-on-Trent Trunk Road (Blythe Bridge to Queensway and Connecting Roads) (Side Roads) Order 1992 be varied.

The Order to be varied authorises:

- (a) the improvement of highways,
- (b) stopping-up of highways,
- (c) creation of new highways,
- (d) stopping-up of private means of access to premises, and
- (e) creation of new means of access to premises.

The Variation Order is a consequence of the Highways Agency's agreement to acquire Nos. 19-29 Tweed Street plus the adjacent garages. The properties and garages are to be demolished and this Variation Order provides for the stopping-up of an additional section of Tweed Street along the frontage of the properties, to prohibit its use by vehicular traffic. A footpath route will be maintained. The Variation Order also deletes a proposed turning head which was intended to serve vehicles visiting the properties.

The Schedule in the Variation Order also corrects various omissions from the original Schedule but does not change the provisions of the Order as shown on the Order plan.

Any person may object to the making of the Order not later than 24th August 1994, or within six weeks from the date of first publication of this notice if that period expires later, by notice to the Secretary of State at the office of the Director (West Midlands Construction Programme Division) Highways Agency, No. 5 Broadway, Broad Street, Birmingham B15 1BL quoting Ref. WMT 254/8/65/2/07 and stating the grounds of objection. In the preparation of an objection and the statement of grounds of objection it should be borne in mind that the substance of any objection or representation may be communicated to other people who may be affected by it.

## DISEASES OF FISH ACT 1937

Notice is hereby given that the Minister of Agriculture, Fisheries and Food having reasonable grounds for suspecting that certain inland waters and land adjacent to them are infected areas, has made the Diseases of Fish (Designated Areas) (England) (No. 13) Order 1994.

The Order designates that area for the purpose of section 2 of the Diseases of Fish Act 1937, and restricts the movement of live fish and eggs of fish without the previous consent, in writing, of the Minister of Agriculture, Fisheries and Food.

The Order came into force on 30th June 1994.
