NEW ROADS AND STREET WORKS ACT

HERTFORDSHIRE COUNTY COUNCIL

NEW ROADS AND STREET WORKS ACT 1991, SECTION 58

Notice of Substantial Roadworks

Three months notice is hereby given that Hertfordshire County Council Transportation Design Services intend to carry out the substantial roadworks at the locations specified in column 1 of the Schedule hereto.

- The street/road in which these works will take place is specified in column 2 of the said Schedule.
- The work is expected to affect the carriageway/footway specified in column 3 of the said Schedule.
- The work is expected to commence on the corresponding dates specified in column 4 of the said Schedule.
- The area and extent of the Works notified are specified in column 5 of the said Schedule.
- Subject to the exceptions in the Act and Regulations under it, no streetworks may be executed for a period of 12 months from completion of the works described in paragraph 5 without the consent of Hertfordshire County Council Transportation Design Services which shall not be unreasonably withheld.
