The A5092 Trunk Road (Greenodd to Penny Bridge) (40 miles per hour Speed Limit) Order 199

The Secretary of State for Transport hereby gives notice that he proposes to make in Order entitled "The A5092 Trunk Road (Greenodd to Penny Bridge) (40 miles per hour Speed Limit) Order 199" under section 84(1)(a) and (2) of the Road Traffic Regulation Act 1984, the effect of which will be to impose a 40 miles per hour speed limit on a length of the trunk road between Greenodd and Penny Bridge, in the County of Cumbria from a point 184 metres north of the intersection of the centre line of the C5022 (Arrad Foot-Colton County Road) with the trunk road to the junction of the trunk road with the A590.

ROAD TRAFFIC REGULATION ACT 1984

De-restriction of the A54 Trunk Road (Chester Road) at Tarvin and Kelsall, in the City of Chester

ROAD TRAFFIC REGULATION ACT 1984

The A59 Trunk Road (Liverpool Road, Penwortham) (Prohibition of Waiting) Order 1994

Notice is hereby given that the Secretary of State for Transport has made an Order under sections 1(1), 2(1) and (2), 3(2) and 4(1) of the Road Traffic Regulation Act 1984, on the A59 Trunk Road, (Liverpool Road) at Penwortham in the Borough of South Ribble in the county of Lancashire.

The effect of the Order will be to prohibit waiting, loading and unloading at any time on any day in that length of the trunk road specified in the Schedule to this Notice.

Exceptions have been provided in the Order to enable a vehicle to be used:

- by a local authority or water company in pursuance of its statutory powers or duties;
- to wait while any gate or other barrier at the entrance to premises to which the vehicle requires access, or from which it has emerged, is being opened or closed (if it is not reasonably practicable for the vehicle to wait elsewhere);

or, when the person in control of the vehicle is required to stop;

- by law;
- in order to avoid an accident;
- due to circumstances outside the person's control.

Anyone wishing to question the validity of the Order, or any of its provisions, on the grounds that:

- it is not within the powers contained in the above Act, or
- any requirement of that Act or any relevant regulations made under it have not been complied with,

may apply for the purpose to the High Court before 19th August 1994.
