RUSHMOOR BOROUGH COUNCIL

Rushmoor Borough Council (Various Roads in Aldershot) (Street Parking Places and Prohibition of Waiting and One-Way) Order 1994.

- (7) To amend the present residents' parking scheme so that it operates between the hours of 9 a.m. and 5 p.m. only, in the roads specified in Schedule 5 below.
- (8) To permit residents' parking only, between 9 a.m. and 5 p.m., in the lengths of road specified in Schedule 6 below.

Waiting Prohibited at any time

Birchett Road, south side from a point in line with the western boundary of No. 23 Birchett Road in an easterly direction to a point 93 feet west of its junction with Gordon Road.

Grosvenor Road, east side from a point 40 feet south of its junction with Victoria Road in a southerly direction to a point 35 feet north of its junction with Birchett Road.

Elms Road, north side:

Between points 35 feet and 109 feet east of its junction with Grosvenor Road.

From a point in line with the western boundary of No. 43 Elms Road in an easterly direction to a point in line with the eastern boundary of No. 53 Elms Road.

The Grove, west side between points 40 feet and 307 feet north of its junction with Lysons Road.

Roads in which existing Residents' Parking Scheme will now operate from 9 a.m. to 5 p.m.
