Notice of application for a licence to abstract water

Take notice that W. H. C. Peacock & Co., of Sunderland Farm, Docking, Kings Lynn, Norfolk, is applying to the National Rivers Authority for a licence to abstract water from the chalk strata at National Grid Reference TF 787 393, at Docking in the district of West Norfolk, in the County of Norfolk. The proposal is to abstract water at the following rates: 93.6 cubic metres per hour; 2,153 cubic metres per day; and 180,000 cubic metres between 1st April and 30th September each year. The water will be used for spray irrigation. This application is for the renewal of an existing licence No. 6/33/66/G/34. There will be no changes in the quantities abstracted.

Notice of application for a licence to abstract water

Bassetlaw District Council (Off-Street Parking Places Variation No. 1) Order 1994

The County Council of Cleveland (A173 North Skelton Road) (Restricted Roads) Order 1994
