There is no exemption for disabled persons' vehicles unless such vehicles are displaying a valid permit under the Order, otherwise the usual exemptions apply, including exemptions for doctors, nurses, midwives and home helps visiting adjacent properties.

The operative times for the Order will be 24 hours/seven days a week.

A copy of the Order, relevant plans and guidelines on the operation of the scheme, together with a statement of the Council's reasons for proposing to make the Order, may be examined at the Information Desk, Town Hall, Blackburn, and at the Town Hall, Darwen, on Mondays to Fridays inclusive, between the hours of 10 a.m. and 4 p.m. (excluding Bank Holidays).
