Now therefore the Secretary of State, in exercise of the powers conferred on him by section 29 and paragraph 4(2) of Schedule 11 to the Wildlife and Countryside Act 1981 and of all the other powers enabling him in that behalf, hereby makes the following amending Order:

1. The Lindisfarne (Northumberland) Nature Conservation Order 1993 shall be amended as follows:

(a) for the words on the map annexed to the Order "(Extends to 6 metres below Mean Low Water)", there shall be substituted the words, "(Extends to 6 metres seawards of the line of Mean Low Water)"; and

(b) in Schedule 2 to the Order, for the words "Bait digging" there shall be substituted the words, "the removal of any fauna for use as bait, whether by digging, bait pump, or any other means".

This Order may be cited as the Lindisfarne (Northumberland) Nature Conservation Order 1994.
