CHELTENHAM BOROUGH COUNCIL

The Borough of Cheltenham (Winchcombe Street) (Designation and Regulation of Street Parking) Order 1994

Notice is hereby given that Cheltenham Borough Council proposes to make an Order in pursuance of sections 1, 2, 4, 32 and 35 and paragraph 27 of Part IV Schedule 9 of the Road Traffic Regulation Act 1984, the effect of which will be:

1. To provide an on-street parking place for 5 vehicles in part of the north-west side of Winchcombe Street.
2. During the hours of 8 a.m. to 6 p.m. on Mondays to Saturdays:
 - (a) only vehicles lawfully displaying a disabled persons badge may use the Parking Place;
 - (b) vehicles will be permitted to park in the Parking Place for a maximum period of 1 hour;
 - (c) vehicles will be prohibited from returning to the Parking Place within 1 hour of a previous period of waiting during the said hours;

3. No person may leave a vehicle in the Parking Place except wholly within a parking space;
4. The proposed Order will contain exemptions to permit a vehicle to wait during the hours mentioned above whether or not within a parking space, if it is:
 - (a) being used for police, fire brigade or ambulance purposes;
 - (b) being used by a local authority or public utility undertaking in pursuance of statutory powers.
5. To revoke those parts of the Borough of Cheltenham (Central Area) (Pedestrian Priority) Order 1987 which:
 - (a) prohibit vehicles from waiting between the hours of 8 a.m. to 6 p.m. on Monday to Saturday in part of the north-west side of Winchcombe Street;
 - (b) prohibit vehicles from waiting at any time in part of the north-west side of Winchcombe Street.
