Notice of application for a licence to abstract water

Take notice that Pointing Ltd. of Prudhoe Industrial Estate, Prudhoe, Northumberland, is applying to the National Rivers Authority for a licence to abstract water from the Coal Measures Strata. National Grid References NZ 08926355 and NZ 08966358 at Prudhoe Industrial Estate, Prudhoe, Northumberland. The proposal is to abstract water at the following rates: 40.0 cubic metres per hour, 960 cubic metres per day, 200,000 cubic metres (per year). The water will be used for general industrial purposes, non-evaporative cooling and effluent dilution.

A copy of the application and any map, plans and other documents submitted with it may be inspected, free of charge, at all reasonable hours at Pointing Ltd., Prudhoe Industrial Estate, between 23rd July and 25th August 1994.

BARROW-IN-FURNESS BOROUGH COUNCIL

The County of Cumbria (Borough of Barrow-in-Furness) (Greengate Street) (Parking Places) Order 1994

Notice is hereby given that on 19th July 1994 the Council of the Borough of Barrow-in-Furness made the above Order under the provisions of the Road Traffic Regulation Act 1984 the effects of which are also set out below:

Street Parking Places—waiting limited to 2 hours (return prohibited within 4 hours) (between 8 a.m. and 6 p.m., Monday to Saturday inclusive—permit holders exempt from time limit).

Greengate Street:

North-western side from a point 51 metres north-east of its junction with Rawlinson Street for a distance of 50 metres in a north-easterly direction.

Both sides from a point of 20 metres north-east of the centre of its junction with Sutherland Street for a distance of 70 metres in a north-easterly direction.

Residents permits will be available to residents of Greengate Street, subject to no more than two resident's permits being issued in respect of any one address. In addition, visitors permits will be available to any such resident, subject to no more than one visitor's permit being issued in respect of any one address.

Copies of this Order which comes into operation on 22nd August 1994 and statement of the Council's reasons for making this Order are available for inspection at the Council's offices at the Town Hall, Duke Street, Barrow-in-Furness, between the following hours:

Monday to Thursday—8.30 a.m. and 5 p.m.

Friday —8.20 a.m. and 4 p.m.

Any person who wishes to question the validity of these Orders or of any provision contained in them on the grounds that they are not within the powers conferred by the Road Traffic Regulations Act 1984 or on the grounds that any requirements of that Act or of any Instrument made under it has not been complied with in relation to any of the Orders may within 6 weeks of the date on which that Order was made, make an application for that purpose to the High Court.

BERKSHIRE COUNTY COUNCIL

Royal County of Berkshire (Various Bus Lanes, Reading) (Amendment) (Experimental) (No. 2) Order 1994

Notice is hereby given that the County Council of the Royal County of Berkshire has made an Order under section 9 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, the effect of which is to extend the categories of vehicles (currently buses, school buses, works buses, cycles and hackney carriages*) which are allowed to use the bus lanes listed below to include all buses providing public passenger transport services within the meaning of the Transport Act 1985. In particular, these include the patient transfer services of the Ambulance NHS Trust, Social Services transport, Dial-A-Ride and other minibus services for the elderly and disabled:

Norcot Road, Reading.
Oxford Road, Reading.
Southcote Road, Reading.
Bath Road, Reading.
Stanshawe Road, Reading.
Friar Street, Reading.
West Street, Reading.
Oxford Road/Bedford Road, Reading.
St. Mary's Butts, Reading.
Broad Street, Reading.
London Street/Duke Street, Reading.
Bridge Street, Reading.
London Road, Reading.
Eldon Road, Reading.
Kings Road, Reading.
Wokingham Road, Reading.
Church Street, Caversham.
Hamdean Road, Caversham.

(*Hackney carriages not currently allowed in Friar Street and London Street/Duke Street bus lanes but will be permitted under the terms of the Order).

The Order was made on 22nd July 1994, and will come into operation on 2nd August 1994, for a maximum period of 18 months.

A copy of the Order, Orders to be amended or revoked, a map showing the affected lengths of highway, a statement of the Council's reasons for making the Order and a statement setting out the Council's reasons for proceeding by way of experiment and whether the Council intends to consider making a permanent Order in like terms may be inspected between the hours of 9 a.m. and 4.30 p.m., Mondays to Fridays, at the offices of Reading Borough Council, Civic Offices, Reading and at the County Solicitors' office.

The Council will be considering in due course whether the provisions of the Order should be continued in force indefinitely. Within a period of 6 months from 22nd July 1994 (or if the Order is subsequently varied by another Order under section 9 of the Act or modified pursuant to subsection (2) of section 10 of the Act, from the coming into operation of that variation or modification whichever is the latest) any person may object to the making of an Order for the purposes of such indefinite continuation. Any such objection must be in writing, must give the grounds on which it is made and must be sent to the undersigned.

If you wish to question the validity of the Order or any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or any Instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 22nd July 1994 apply to the High Court for this purpose.
