

Avenue, on the northern side from its junction with Palace Street East eastwards for approximately 65 metres (the whole length).

Palace Street East:

On the western side from a point approximately 3 metres south of the southern channel of Silver Street southwards for approximately 51 metres.

On the western side from a point approximately 2 metres south of the southern channel of Oil Mill Lane southwards for approximately 19 metres.

On the western side from a point approximately 2 metres south of the southern channel of Weddells Lane southwards for approximately 27 metres.

Palace Green:

On the northern side from a point approximately 4 metres west of the western channel of Palace Street East westwards for approximately 27 metres (outside No's. 2-10).

On the western side from a point approximately 6 metres north of the northern channel of the east-west part of Palace Green northwards for approximately 7 metres (outside No. 22).

On the western side from a point approximately 17 metres north of the northern channel of the east-west part of Palace Green northwards for approximately 29 metres (outside Nos. 14-20).

On the northern side from a point approximately 7 metres east of the eastern channel of Palace Street eastwards for approximately 20 metres.

Palace Street:

On the northern side from a point approximately 15 metres east of the eastern channel of Sandgate eastwards for approximately 8 metres.

On the northern side from a point approximately 45 metres east of the eastern channel of Sandgate eastwards for approximately 14 metres (outside No's. 13-15).

On the western side from a point approximately 43 metres south of the eastern channel of Sandgate southwards for approximately 60 metres.

On the eastern side from a point approximately 5 metres south of the junction with Foul Ford southwards for approximately 46 metres.

Parade, on the southern side from a point approximately 5 metres east of the eastern channel of Church Street eastwards for approximately 73 metres.

Hatters Lane, at the northern end from the eastern channel to the western channel.

Coxons Lane:

On the eastern side from a point approximately 1 metre north of the projection of the northern channel of College Place northwards for approximately 17 metres.

On the western side from a point approximately 73 metres north of the northern channel of Walkergate northwards for approximately 20 metres.

Greenside Avenue, from its junction with College Place westwards for approximately 100 metres (the whole length).

College Place, from its junction with Coxons Lane westwards to its junction with Greenside Avenue (the whole length).

Unnamed area to the west of Love Lane/Bridge Terrace, on the north-western side from the south-western channel of Bridge Terrace northwards for approximately 13 metres.

Eastern Lane, on the south-eastern side from a point approximately 8 metres south of the southern channel of Easter Wynd southwards for approximately 18 metres.

Scotts Place:

On the western side from a point approximately 9 metres south of its junction with Brucegate southwards for approximately 32 metres.

On the north-eastern side from a point approximately 2 metres west of the western channel of Wellclose Square northwards for approximately 16 metres.

Tweed Street:

On the southern side from a point approximately 9 metres west of the western channel of Castlegate westwards for approximately 36 metres.

On the western side from a point approximately 98 metres south of the projection of the southern channel of Railway Street southwards for approximately 36 metres.

On the western side from a point approximately 142 metres south of the projection of the southern channel of Railway Street southwards for approximately 9 metres.

Castlegate:

On the north side (north of the War Memorial) from a point approximately 2 metres east of the main eastern channel of Castlegate eastwards for approximately 36 metres (outside No's. 88-96).

On the north side (between the War Memorial and the footpath to High Greens) from a point approximately 47 metres east of the main eastern channel of Castlegate eastwards for approximately 17 metres (outside No's. 80-84).

Oil Mill Lane, on the southern side from a point approximately 3 metres west of the western channel of Palace Street East westwards for approximately 12 metres.

Church Street:

On the eastern side from a point approximately 2 metres south of the southern channel of Parade southwards for approximately 32 metres.

On the eastern side from a point approximately 42 metres south of the southern channel of Parade southwards for approximately 32 metres.

Wallace Green, on the western side from a point approximately 83 metres north of the northern channel of Walkergate northwards for approximately 10 metres.

- To introduce a residents parking scheme on the following lengths of road in Berwick Town Centre:

9 a.m. to 5.30 p.m. Monday to Saturday

Castlegate, across the eastern end of the part of Castlegate which runs west east to the north of the War Memorial.

High Greens, on the northern side from a point approximately 10 metres east of the eastern channel of Bell Tower Park eastwards for approximately 57 metres.

Brucegate:

On the eastern side from a point approximately 94 metres south of the southern channel of Low Greens southwards for approximately 28 metres.

On the western side from a point approximately 11 metres north of the junction with Scotts Place northwards for approximately 11 metres.

On the western side from a point approximately 27 metres north of the junction with Scotts Place northwards for approximately 12 metres.

- To rescind the residents parking scheme on the following lengths of road in Berwick Town Centre:

Palace Green:

On the southern side from the eastern end westwards for approximately 83 metres.

On the southern side from a point approximately 90 metres west of the eastern end westwards for approximately 23 metres.

On the western side from a point approximately 2 metres north of the northern channel of the east west part of Palace Green northwards for approximately 40 metres.

On the eastern side from a point approximately 3 metres north of the northern channel of the east west part of Palace Green northwards for approximately 44 metres.

Exemptions for certain necessary purposes are included in the Order.

This Order hereby revokes the following:

"The County of Northumberland (Berwick Town Centre) (Residents Parking) Order 1993"

Full details are included in a copy of the confirmed Order which together with a map showing the lengths of road involved and a statement of the Council's reasons for making the Order may be examined at the offices of the Chief Executive, Berwick-upon-Tweed Borough Council, Wallace Green, Berwick-upon-Tweed TD15 1ED and at the address shown below until 7 September 1994.

If you wish to question the validity of the Order or any of the provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirements of that Act or any Instrument made under it has not been complied with in relation to the Order, you may within 6 weeks from 27th July 1994 apply to the High Court for that purpose.
