UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT 1923

TOWN AND COUNTRY PLANNING ACT 1990

The Stopping-up of Highways (Little Chippenham, Monmouth, Gwent) Order 1994

The Secretary of State for Wales hereby gives notice that he has made an Order under section 247 of the Town and Country Planning Act 1990, to authorise the stopping-up of the highway described in the Schedule to this notice to enable development consisting of car parking and the relocation of an electricity substation associated with the warehouse food store development, for which planning permission has been granted, to be carried out.

If any person desires to question the validity of the Order, or of any provisions contained therein, on the grounds that it is not within the powers of the Town and Country Planning Act 1990; or that his interests have been substantially prejudiced by a failure to comply with any of the requirements of that Act, he may, within 6 weeks of 28th July 1994, apply to the High Court for the suspension or quashing of the Order, or of any provision contained therein.
