

(iv) the charge in connection with the issue of permits for the use of the parking place will be £45.00 per parking place and that the permits will be valid for a period of 12 months.

3. The requirements mentioned in 2(a) and (b) above would not apply to anything done:

- (a) with the permission or at the direction of a police constable in uniform;
- (b) in accordance with any restrictions or requirement indicated by traffic signs placed on the highway by or on behalf of the Metropolitan Police.

Disabled Persons Parking Places, Revocation and Designation

Notice is hereby given that the Islington Borough Council on 25th July 1994, made the Islington (Free Parking Places) (Disabled Persons) (No. 4) Order 1994 under section 6 of the Road Traffic Regulation Act 1984.

The general effect of the Order will be to:

- (a) revoke the present Disabled Person's Parking Places in *Canning Road, Elizabeth Avenue* and *Riversdale Road*.
- (b) designate new parking places in *Biddestone Road, Carleton Road, Cheverton Road, Eburne Road, Elizabeth Avenue, Greenman Street, Hatley Road, Lennox Road, Medina Road, Moray Road, Pleshey Road, Ripplevale Grove, St. Thomas' Road, Shaftesbury Road, Whitehall Park and Witley Road*.
- (c) provide that the parking places will operate between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive (Christmas Day, Good Friday and Bank Holidays excepted);
- (d) specify, in respect of the parking places, that a disabled person's vehicle displaying in the relevant position, a disabled person's badge (commonly referred to as "the Orange Badge") issued by any Local Authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1975 or 1982 may be left therein; and
- (e) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes) to load or unload (maximum 20 minutes), etc.

A copy of the Order, of the Islington (Free Parking Places) (Disabled Persons) (No. 1) Order 1980, (and of the Orders which have amended or applied that Order) and of the Council's statement of reasons for making the Order, and of maps which indicate the lengths of road to which the Order relates, can be inspected during normal office hours on Mondays to Fridays inclusive, until the expiration of a period of 6 weeks from the date of this notice at the Legal Department, Town Hall, Upper Street, London N1 2UD.

London Borough of Redbridge (Doctor Parking Places) (Amendment No.) Order 1994

(Free Parking Places) (Amendment No.) Order 1994 *Blenheim Avenue, Gants Hill*

Notice is hereby given that the Council of the London Borough of Redbridge propose to make the above-mentioned Orders, in exercise of the powers conferred by sections 6, 45, 46, 49, 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The general effect of the Doctors Parking Places Order, which will further amend the Redbridge (Doctor Parking Places) (No.) Order 1984, will be to:

- (a) *Blenheim Avenue*, the south-west side, from a point 12.80 metres north-west of the north-western kerb-line of Cranbrook Road for a distance of 5 metres north westwards.
- (b) provide that a permit may be issued by the Council of the London Borough of Redbridge on application being made by a legally qualified medical practitioner;
- (c) provide that the parking place will be in operation between 8 a.m. and 8 p.m. on any day of the week;
- (d) provide that the charge for the permits for the use of each of the parking places will be £65 and that that permits will be valid for a period of 12 months.

(NOTE: Permits in respect of the parking place in Blenheim Avenue, Gants Hill will be issued only in connection with the surgery at 463 Cranbrook Road).

The general effect of the Free Parking Order, which will further amend the Redbridge (Free Parking Places) Order 1993, will be to adjust the length of free parking places in Blenheim Avenue so as to accommodate the Doctors Parking Place detailed in paragraph 2 above.
