- (ii) on both sides of Princess Street in a southerly direction for 10 metres from its junction with High Street (G/W)
- (iii) on both sides of High Street from a point 15 metres east of the junction with Holly Grove Lane/Princess Street to a point

15 metres west of the junction, a distance of 30 metres (C/L).

High Street/Railway Lane:

- (i) on both sides of Railway Lane in a northerly direction for 10 metres from its junction with High Street (G/W)

Eastgate Street/Princess Street:

- (i) on both sides of Eastgate Street in a westerly direction for 10 metres from its junction with Princess Street (G/W)
- (ii) on both sides of Eastgate Street in an easterly direction for 10 metres from its junction with Princess Street (G/W)
- (iii) on both sides of Princess Street from a point 15 metres south of its junction with Eastgate Street to a point 15 metres north of the junction, a total distance of 30 metres (C/L).

Lorne Street/Princess Street:

- (i) on both sides of Lorne Street in a westerly direction for 10 metres from its junction with Princess Street (G/W)
- (ii) on both sides of Princess Street from a point 15 metres south of its junction with Lorne Street to a point 15 metres north of the junction, a distance of 30 metres (C/L).

Exceptions permit waiting for the purposes of taking up and setting down of passengers, loading or unloading goods, for vehicles displaying a Disabled Persons's Badge, and where necessary in connection with the maintenance of roads and the supply of gas, electricity and water; for emergency service vehicles; for buses waiting at an authorised bus stop; and for vehicles being used for floods defence works or land drainage works. The Order will permit the waiting of vehicles for so long as is reasonably necessary in connection with any wedding or funeral.

The Order is called the Staffordshire County Council (High Street Area, Chase Terrace) (Prohibition of Waiting) Order 1994.

Staffordshire County Council on 28th July 1994 made a Traffic Order under sections 1(1) and (2), 2(1) to (3) of the Road Traffic Regulation Act 1984, which prevents you from driving your vehicle in an westerly direction on the following roads:

Lorne Street, Chase Terrace – between Chapel Street and Princess Street.

Eastgate Street, Chase Terrace-between Ironstone Road and Princess Street.

The Order is called the Staffordshire County Council (One-way Traffic) (Lorne Street and Eastgate Street, Chase Terrace) Order 1994.

Full details are in the Orders which, together with a map showing the roads involved, may be examined during normal office hours at my office; at the office of the County Surveyor, Highways House, Riverway, Stafford, and during normal opening hours at Burntwood Library, Sankey's Corner, Chase Terrace.
