## ROAD TRAFFIC ACTS

### BARNSELEY (METROPOLITAN BOROUGH COUNCIL)

*The Metropolitan Borough of Barnsley (Barnsley) (Traffic Regulation Consolidation) Order 1987 (Amendment No. 36) Order 1994.*

Notice is hereby given that on 22nd July 1994, the Barnsley Metropolitan Borough Council made an Order under the provisions of the Road Traffic Regulation Act 1984 (as amended).
