The Hertfordshire (Ormskirk Road, South Oxhey, Watford Rural) (Prohibition of Entry and Driving) Order 1994

Notice is hereby given that the Hertfordshire County Council propose to make an Order under the Road Traffic Regulation Act 1984, the effect of which will be to:

- (i) prohibit any vehicle proceeding along Ormskirk Road, South Oxhey, Watford Rural entering Little Oxhey Lane.
- (ii) prohibit any vehicle proceeding along Little Oxhey Lane, South Oxhey, Watford Rural from entering Ormskirk Road.

The provisions of the county of Hertfordshire (Ormskirk Road, Oxhey) (One-way) Order 1973 will be revoked to permit two way traffic in Ormskirk Road.

A copy of the proposed Order, and a plan showing the road to which the Order relates together with a statement of reasons for proposing to make the Order may be inspected at the Watford Borough Council Offices at Town Hall, Watford, and at Hertfordshire County Council offices at Room 223A, County Hall, Hertford.

Objections to the proposals must be made in writing to the undermentioned person stating the grounds on which they are made by 22nd August 1994.

The Hertfordshire (High Street, Potters Bar) (Waiting, Loading and Unloading Restrictions) Order 1993

Notice is hereby given that the Hertfordshire County Council have made an Order under sections 1(1), 2(1) to (3), 3 of the Road Traffic Regulation Act 1984, the effect of which is to change and also bring together into 1 Order prohibition and restriction of waiting loading and unloading restrictions in the lengths of High Street, Potters Bar as described in the Schedules to this Notice.

The usual exemptions will apply in relation to the proposed waiting restrictions described in Schedules 1 to 3 to enable persons to board or alight for goods to be loaded and unloaded, statutory duties or the emergency services, or for vehicles being used by disabled persons.

A copy of the Order which will come into operation on 1st August 1994, and a plan showing the roads to which the Order relates may be inspected at Hertsmere Borough Council Offices at Elstree Way, Borehamwood and the Hertfordshire County Council's Offices at Room 223A County Hall, Hertford.

Any person wishing to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of the Act or of any Instrument made under it, has not been complied with in relation to the Order, may within 6 weeks from the date of this Notice, apply to the High Court for this purpose.

SCHEDULE 1

*Lengths of road in Potters Bar
No Waiting at any time**A1000 High Street:*

East side:

- (i) from a point 105 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 16 metres.
- (ii) from a point 154 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 26 metres.
- (iii) from a point 205 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 17 metres.
- (iv) from a point 113 metres south of the centre line of its junction with Salisbury Close northwards to a point 50 metres north of the centre line of that junction.
- (v) from the northern kerb-line of its junction with the access road to the Library Car Park northwards for a distance of 6 metres.

(vi) from a point 26 metres north of the northern kerb-line of its junction with the access road to the Library Car Park northwards for a distance of 15 metres.

(vii) from a point 18 metres south of the southern kerb-line of its junction with Cotton Road northwards to its junction with Cotton Road.

West Side:

(i) from a point 6 metres south of the southern kerb-line of The Walk northwards for a distance of 37 metres.

(ii) from a point 62 metres north of the southern kerb-line of The Walk northwards for a distance of 36 metres.

SCHEDULE 2

Waiting prohibited 8 a.m. to 6.30 p.m. Mondays to Saturdays inclusive

A1000 High Street:

East side:

(i) from its junction with Southgate Road northwards for a distance of 105 metres.

(ii) from a point 90 metres north of the centre line of its junction with Salisbury Close northwards to the southern kerb-line of the access road to the Library Car Park, a distance of approximately 210 metres.

West side:

(i) from its junction with Mutton Lane northwards to a point 110 metres south of the southern kerb-line of its junction with The Walk, a distance of approximately 201 metres.

(ii) from a point 120 metres south of the southern kerb-line of The Walk northwards for approximately 40 metres. (690)

(iii) from a point approximately 210 metres north of the southern kerb-line of The Walk northwards to its junction with Hatfield Road, a distance of approximately 267 metres.

SCHEDULE 3

Waiting limited to 1 hour, no return within 2 hours, Mondays to Saturdays inclusive, 8 a.m. to 6.30 p.m.

High Street:

Marked parking bays on the east side:

(i) from a point 121 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 33 metres;

(ii) from a point 180 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 25 metres;

(iii) from a point 222 metres north of the northern kerb-line of its junction with Southgate Road northwards for a distance of 25 metres;

(iv) from a point 6 metres north of the northern kerb-line of the access road to the Library car park northwards for a distance of 20 metres.

Marked parking bay on the west side, from a point 6 metres south of the southern kerb-line of The Walk southwards for a distance of 32 metres.

West side, marked parking bays on main carriageway:

(i) from a point 110 metres south of the southern kerb-line of The Walk northwards for a distance of 10 metres;

(ii) from a point 37 metres north of the southern kerb-line of The Walk northwards for a distance of 25 metres;

(iii) from a point 98 metres north of the southern kerb-line of The Walk northwards for a distance of 40 metres;

(iv) from a point 161 metres north of the southern kerb-line of The Walk northwards for a distance of 55 metres.

Waiting limited to 2 hours, no return within next 2 hours, 8 a.m. to 6.30 p.m., Mondays to Saturdays inclusive

A1000 High Street, east side, from a point 41 metres north of the northern kerb-line of the access road to the Library car park northwards for a distance of 20 metres.

SCHEDULE 5

Loading or unloading prohibited 8 a.m. to 6.30 p.m., Mondays to Saturdays inclusive

A1000 High Street:

East side:

(i) from its junction with Southgate Road northwards for a distance of 25 metres;

(ii) from a point 73 metres south of the southern kerb-line of Oakmere Lane northwards to a point 14 metres north of the northern kerb-line of Oakmere Lane.

West side:
