That length of the A55 Chester-Bangor Trunk Road, being constructed as a dual carriageway trunk road which extends from a point 272 metres east of the centreline of the Madryn Farm access bridge in a westerly direction to a point 1,260 metres north-east of the centrepoint of the Bronydd Isaf bridge (Tal-y-Bont Interchange overbridge). The A487 Trunk Road (Fishguard, Dyfed) (Prohibition of Vehicles or Combinations of Vehicles Exceeding 13 metres in Length) Order 199

Notice is hereby given that the Secretary of State for Wales proposes to make an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to prohibit any vehicle or combination of vehicles exceeding 13 metres in length from proceeding in the length of the trunk road specified in the Schedule to this notice.

The basic alternative route suggested for vehicles affected by this prohibition will be to proceed from Fishguard Square via the A40 Trunk Road to Haverfordwest and Penblewin Crossroads, then via the A478 County Road to Cardigan and then via the A487 Trunk Road, or vice versa depending on the direction of approach. However as drivers should be alerted to the prohibition by the system of advance warning signs which it is proposed to erect and depending on their direction of approach and destination, the alternative route could be shorter.

The A55 Trunk Road (Abergwyngregyn, Gwynedd) (Clearway) Order 199
