- 1. to prohibit waiting at any time on any day in certain lengths of Abbey Road, Abbotts Road, Ardenham Street, Ascott Road, Beaconsfield Road, Bicester Road, Bierton Road, Broughton Avenue, Buckingham Road, Buckingham Street, Cambridge Street, Carlyle Avenue, Chadbone Close, Church Street, Clinton Crescent, Croft Road, Eastern Street, Evett Close, Friarscroft Way, Grecian Street, Green End, Griffin Lane, High Street, Highbridge Road, Kings Road, Kingsbury, Manor Road, Mill Street, Mount Pleasant, Norfolk Terrace, Oakfield Road, Parsons Fee, Pembroke Road, Princes Road, Queens Park, Rose Avenue, St. Johns Road, St. Johns Street, Station Way, Stirling Avenue, Stocklake, Temple Street, Tindal Road, Turnfurlong, Vale Road, Walton Dene, Walton Grove, Walton Lodge Lane, Walton Road, Walton Way, Wendover Road, West Street, Willow Road and the unnamed access road from Walton Road to the new development;

If you wish to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of that Act or of any instrument made under it has not been complied with in relation to the Order, you may, within 6 weeks from 1st November 1994, apply to the High Court for this purpose.
