#### ROAD TRAFFIC REGULATION ACT 1984

##### *The A1 Trunk Road (Russell Hill, Thornhaugh, Cambridgeshire) (Prohibition of Right Turns and U-Turns) Order 199*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 1(1), 2(1) and (2) of the Road Traffic Regulation Act 1984 and all other enabling powers, on the A1 Trunk Road, known as the Great North Road.

The effect of this Order will be to prohibit vehicles from:

- (a) turning right out of Russell Hill, Thornhaugh onto the southbound carriageway of the A1,
- (b) turning right from the southbound carriageway of the Trunk Road into Russell Hill, Thornhaugh,
- (c) turning right from the northbound carriageway of the A1 opposite its junction with Russell Hill, Thornhaugh to the properties known as 6, 8, 10 and 12 Great North Road,
- (d) making U-turns through the gap in the central reservation opposite the junction of the trunk road with Russell Hill, Thornhaugh.

#### ROAD TRAFFIC REGULATION ACT 1984

##### *The A1 Trunk Road (Windgate Way, Thornhaugh, Cambridgeshire) (Prohibition of Use of Gap in Central Reservation) Order 199*

The Secretary of State for Transport hereby gives notice that he proposes to make an Order under sections 1(1), 2(1) and (2) of the Road Traffic Regulation Act 1984 and all other enabling powers, on the A1 Trunk Road, known as the Great North Road.

The effect of this Order will be to prohibit vehicles proceeding in either of the carriageways of the A1 Trunk Road from proceeding through the gap in the central reservation opposite the junction of that road with Windgate Way, Thornhaugh.
