To introduce prohibition of waiting at any time on the following lengths or sides of roads

Dillwyn Road:

East side, from a point 10 metres north of the northern kerb-line of Gorseinon Road for a distance of 18 metres in a northerly direction.

West side, from a point 9 metres north of the northern kerb-line of Gorseinon Road for a distance of 24 metres in a northerly direction.

SCHEDULE 2

To introduce 30 m.p.h. Speed Restriction Order

Swansea Road, from a point approximately 175 metres south-east of the eastern kerb-line of the western access lane to Morris Terrace for a distance of 390 metres in a north-westerly direction.

Gorseinon Road, from a point approximately 20 metres west of its junction with Phoenix Way for a distance of approximately 1,290 metres in a westerly direction.

GWENT COUNTY COUNCIL

Gwent County Council (Herbert Avenue, Risca) (Prohibition of Waiting) Order 1994
