

## THAMESDOWN BOROUGH COUNCIL

*The Borough of Thamesdown (Cycle Tracks, Stratton St. Margaret) (Prohibition of Driving) Order 1994*

Notice is hereby given that the Thamesdown Borough Council as agent to the Wiltshire County Council proposes to make an Order under sections 1(1), 2(1) to (3) and 3(2) of the Road Traffic Regulation Act 1984, the effect of which will be:

1. To prohibit any motor vehicles from using the length of cycle track which runs from Derwent Drive (adjacent to No. 81) to Hyde Road.
2. To revoke the Prohibition of Cycling Order on the footpath which runs alongside Hyde Road and connects with Derwent Drive (alongside No. 81 and No. 48).

The effect of this is to provide cyclists with a safe route between Kingsdown School and Derwent Drive.

*The Wigan Borough (Banks Court, Leigh) (Prohibition of Waiting and Restriction of Loading) Order 1994*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Banks Court, Leigh) (Prohibition of Waiting and Restriction of Loading) Order 1994.

The effect of the Order will be to:

1. Introduce waiting restrictions to apply at all times on:
  - (a) *Banks Court*—both sides from the junction with Wigan Road for a distance of 15 metres;
  - (b) *Wigan Road*—west side from a point 15 metres north of Banks Court to a point 15 metres south of Banks Court.
2. Introduce loading restrictions to apply between the hours of 7.30 a.m. to 9.30 a.m. Monday to Saturday and 4 p.m. to 6.30 p.m. Monday to Friday on:
  - (a) *Banks Court*—both sides from the junction with Wigan Road for a distance of 15 metres;
  - (b) *Wigan Road*—west side from a point 15 metres north of Banks Court to a point 15 metres south of Banks Court.
3. Revoke The Greater Manchester County (Various Roads, Leigh and Hindley) (Prohibition and Restriction of Waiting) (No. 2) (County) Order 1975 in so far as it relates to Wigan Road.

There will be limited exceptions permitting vehicles to wait—

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Ltd. and Post Office purposes;
- (d) if the vehicles are fire service or police vehicles or ambulances;
- (e) to take on fuel, water or air at any garage.

*The Wigan Borough (Derby Street/Wharf Street, Leigh) (Prohibition of Waiting) Order 1994*

Notice is hereby given that the Wigan Borough Council, in exercise of the powers under section 1 of the Road Traffic Regulation Act 1984, proposes to make the Wigan Borough (Derby Street/Wharf Street, Leigh) Order 1994.

The effect of the Order will be to introduce a prohibition of waiting on:

- (a) *Wharf Street*—west side from Derby Street for a distance of 73 metres in a northerly direction to cul-de-sac end.
- (b) *Derby Street*—south side from a point 35 metres west of Wharf Street for a distance of 33 metres in a westerly direction.
- (c) *Derby Street*—north side from a point 35 metres west of Wharf Street to its junction with Brown Street South.
- (d) *Brown Street South*—east side from a point 20 metres south of Spinning Jenny Way to its junction with Derby Street.

- (a) to enable people to board or alight;
- (b) for the purpose of building and similar operations, removing obstructions to traffic, road works and works by statutory undertakers;
- (c) for local authority, North West Ltd. and Post Office purposes;

- (f) for the delivery or collection of goods for loading or unloading.
