The A55 and A494 Trunk Roads (Ewloe, Clwyd) (Prohibition of Cyclists) Order 1994

Notice is hereby given that on 25th october 1994, the Secretary of State made the above Order which will come into operation on 7th November 1994.

THE HIGHWAYS ACT 1980 ACOUISTION OF LAND ACT 1981

Notice is hereby given that public local inquiries in connection with the Orders mentioned below will be held by J. H. Brown RIBA (a person appointed for the purpose by the Secretary of State for Wales) beginning at 10 a.m. on Tuesday, 13th December 1994, at the Bridgend Recreation Centre, Angel Street, Bridgend, to hear representations from statutory objectors (as defined in the Highways (Inquiries Procedure) Rules 1976 and the Compulsory Purchase by Non-Ministerial Acquiring Authorities (Inquiries Procedure) Rules

1990) and also at his discretion to hear representations from any other persons who may desire to appear and be heard.

The Orders are Orders which have been made by the County Council of Mid Glamorgan and under the above-mentioned Acts and submitted to the Secretary of State for confirmation and are:

- The Mid Glamorgan County Council (Route A4061 Bridgend Cross Valley Link) (Side Roads) Order 1994. This is an Order under sections 14 and 125 of the Highways Act 1980 which, if confirmed, will authorise the Council;
 - (a) to improve, raise, lower or otherwise alter highways,
 - (b) to stop-up highways;
 - (c) to construct new highways;
 - (d) to stop-up private means of access to premises, and
 - (e) to provide new means of access to premises
 - all on or in the vicinity of the route of the classified road which the Council are proposing to construct from a new junction with Park Street and Angel Street to connect with the proposed A4061 Bridgend Northern Distributor Road east of Green Street, Bridgend.
- 2. The Mid Giamorgan County Council (Route A4061 Bridgend Cross Valley Link) Compulsory Purchase Order 1994. This is an Order under sections 239, 240, 246, 250 and 260 of the Highways Act 1980 which, if confirmed, will authorise the Council to purchase compulsorily the land and rights described therein for the purpose of:
 - (a) the construction of a highway from a new junction with Park Street and Angel Street in a general northerly direction to a new junction with Tondu Road (A4063) and then in a general easterly direction to include a proposed circulatory junction with Coity Road and Tremains Road and then in a general north-easterly direction to connect with the proposed A4061 Bridgend Northern Distributor Road, the whole route being within the Borough of Ogwr, in the county of Mid Glamorgan and designated "The Bridgend Cross Valley Link"
 - within the Borough of Ogwr, in the county of Mid Glamorgan and designated "The Bridgend Cross Valley Link".

 (b) the stopping-up of existing highways and the construction of new highways; the improvement and realignment of existing highways in the vicinity of the route of the above-mentioned highway in pursuance of The Mid Glamorgan County Council (Route A4061 Bridgend Cross Valley Link) (Side Roads) Order 1994
 - (c) the stopping-up of private means of access and the provision of new means of access to premises in pursuance of The Mid Glamorgan County Council (Route A4061 Bridgend Cross Valley Link) (Side Roads) Order 1994
 - (d) the diversion of watercourses and the carrying out of other works on watercourses in connection with the
