The East Sussex (A267 Five Ashes) (40 m.p.h. Speed Limit Extension) Order 1994

Any person wishing to question the validity of the Order or any of its provisions on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act of 1984, or on the grounds that any requirement of the Road Traffic Act or of any Instrument made under it has not been complied with in relation to the Order, may within 6 weeks of 2nd November 1994 apply to the High Court for this purpose.
