NEW ROAD AND STREET WORKS ACT 1991, SECTION 58 (ENGLAND AND WALES)

Notice of Substantial Road Works (England and Wales)

Three months advance notice is hereby given that Buckinghamshire County Council (Highway Authority) intends to carry out substantial road works (England and Wales).

- The road in which these works will take place is the A41 Trunk Road (Bicester Road, Aylesbury) and will include carriageway and footway works.
- Work is expected to affect the carriageway between Berryfields and Stone Bridge, Meadowcroft to Henley's roundabout and the footway and verge between Berryfields to Henley's roundabout.
- Work is expected to commence on 27th January 1995 (work should begin within one month of this date).
- The works notified will include the following reconstruction of the road between Meadowcroft and Henley's roundabouts; cycleway construction from Berryfields to Henley's roundabout; and the construction of a right turn at Berryfields along with resurfacing to Stone Bridge.
- Subject to the exceptions in the Act and regulations under it, no street works may be executed for a period of 12 months from completion of the works described in paragraph 5 without the consent of the said Highway Authority, which shall not be unreasonably withheld.
