The relevant notice of proposals was previously published pursuant to Regulation 6(1)(b) of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1989, in Issue No. 53673 of *The London Gazette* dated 13th September 1994, under reference No. 726 and the effect of the Order is as so described in that notice and as set out below save as to such modifications (if any) as are so described.

The Order which comes into operation on 7th November 1994, makes it unlawful for any person to cause any vehicle to wait at any time in the following lengths of road:

- (a) Eric Road, Stubbington, on both sides from its junction with Stubbington Lane, in an easterly direction, for a distance of approximately 40 metres.
