Notice is hereby given that Fareham Borough Council made an Order on 3rd November 1994 pursuant to arrangements made under section 101 of the Local Government Act 1972 with the Hampshire County Council in exercise of the powers of the said County Council under sections 1(1) and (2), 2(1) to (3) and 4(2) of the Road Traffic Regulation Act 1984.

The relevant Notice of Proposals was previously published pursuant to Regulation 6(1)(b) of the Local Authorities' Traffic Orders (Procedure) (England and Wales) Regulations 1989 in Issue No. 53589 of *The London Gazette* dated 15th February 1994 under reference No. 537 and the effect of the Order is as so described in that Notice and as set out below save as to such modifications (if any) as are so described.

The Order which comes into operation on 7th November 1994 makes it unlawful for any person to cause any vehicle:

- To wait in Bath Lane on Monday to Saturday between 8 a.m. and 7 p.m. inclusive on the eastern side from a point approximately 63 metres south of its junction with East Street (ie from the southern end of the lay-by) south-eastwards to the northern boundary of No. 10 Bath Lane.
- 2. To wait at any time in the following lengths of road:
 - (a) The west side from its junction with the southern side of Eastern Way south-eastwards for a distance of 192 metres to its southern end.
 - (b) Both sides of the southern end from the eastern boundary of No. 7 Bath Lane Cottages north-eastwards for a distance of 30 metres.
 - (c) The eastern side from its junction with the southern side of Eastern Way south-eastwards for a distance of 20 metres to the northern boundary of No. 28 Bath Lane.

Insofar as they affect the lengths of road covered by this Order all existing Traffic Regulation Orders are to be revoked.

The Order which comes into operation on 7th November 1994 makes it unlawful for any person to cause any vehicle:

- 1. To wait at any time in the following lengths of road:
 - (a) Colenso Road on the south side from its junction with Trinity Street westwards for a distance of 10 metres.
 - (b) Colenso Road on the south and east side from a point 70 metres north of its junction with Gordon Road northwards then eastwards around the corner for a distance of 20 metres.
 - (c) New Road on both sides from its junction with Gordon Road northwards for a distance of 10 metres.

- (d) New Road on the west and south sides from a point 47 metres north of its junction with Gordon Road northwards then westwards around the corner for a distance of 20 metres.
- (e) New Road on the east and south sides from a point 47 metres north of its junction with Gordon Road northwards then eastwards around the corner for a distance of 20 metres.
- To proceed in Colenso Road in any direction other than a westerly then southerly direction from its junction with Park Lane to its junction with Gordon Road.
- To proceed in Gordon Road in any direction other than an easterly direction between its junction with the east side of Derlyn Rad and its junction with the east side of Colenso Road.

The existing prohibition of waiting restriction on the south side of Colenso Road opposite the recreation ground is revoked.
