Notice of application to vary a licence to abstract water

Take notice that Mr. G. P. Sturdy, of Trigon House, Wareham, Dorset BH20 7TD, is applying to the National Rivers Authority to vary licence serial number 13/44/45/G/005, to abstract water from the Oakdale Sands Strata, part of the Poole Formation at National Grid Reference SY 8938 8959 (Point 1), at Land South of Trigon Hill, Trigon, near Wareham, Dorset. The variation being applied for is Relocation of Water Abstraction Point 1, under licence 13/44/45/G/005 to new National Grid Reference SY 8878 8854. New abstraction point will be closer to main holding and provide better continuity of supply.
