Traffic Calming—Winner Street, Paignton

Notice is hereby given that in order to introduce traffic calming along Winner Street, Paignton, Devon County Council propose to make the following Order under the provisions of the Road Traffic Regulation Act 1984:

The County of Devon (Winner Street, Paignton) (Control of Waiting, Loading and Unloading) Order 1994, the effect of which will be to:

- (a) prohibit waiting and loading/unloading at all times in specified lengths of both sides of Winner Street;
- (b) prohibit waiting at all times in three specified lengths of both sides of Winner Street;
- (c) limit waiting to one hour (no return within one hour) between the hours of 8 a.m. and 6 p.m. Monday to Saturday inclusive within marked bays in specified lengths of both sides of Winner Street; and
- (d) provide marked loading and unloading bays between the hours of 8 a.m. and 6 p.m., Monday to Saturday inclusive in specified lengths of both sides of Winner Street.

The proposed Order will contain the usual exemptions to items (b) and (c) above relating to the picking-up and setting down of passengers, loading and unloading of goods, disabled person's vehicles, the maintenance of the road and telecommunications apparatus and the supply of gas, water and electricity.

Full details of the proposals, together with a plan and a statement of the Council's reasons for the proposals, may be inspected, during normal office hours, at the offices of Torbay Borough Council, Town Hall, Torquay and at Oldway, Paignton.

Objections to the proposals, specifying the grounds on which they are made, must be submitted in writing to the address below to arrive not later than 2nd December 1994.

DONCASTER BOROUGH COUNCIL

South Yorkshire County Council (Various Road, Doncaster) (Traffic Regulation Consolidation) Order 1986 (Amending No.) Order 1994

Notice is hereby given that the Doncaster Borough Council propose to make an Order under the provisions of the Road Traffic Regulation Act 1984.

The effect of the proposed Order will be to:

- (i) Prohibit the waiting by vehicles at any time on those lengths of road or sides of length of road specified in Part I of the Schedule to this notice.
- (ii) Prohibit the waiting by vehicles on Monday to Saturday between 8 a.m. and 6 p.m. on those lengths of road or sides of lengths of road specified in Part II of the Schedule to this notice.

Exceptions to the Order will permit waiting for the purpose of picking up and setting down passengers, loading and unloading goods, in connection with building, industrial or demolition operations, the removal of obstructions to traffic, the maintenance of the roads and the services therein in pursuance of statutory powers or duties and for the collection and delivery of postal packets. The usual exceptions for disabled person's vehicles are also included in the Order.
