MID GLAMORGAN COUNTY COUNCIL

Mid Glamorgan County Council (Lake Street, Union Street and Brook Street, Ferndale) Experimental (One Way Traffic and Prohibition of Waiting) Order 1994.

Notice is hereby given that on 7th November 1994, the Mid Glamorgan County Council made an Order under sections 9 and 10 of the Road Traffic Regulation Act 1984, the effect of which is to experimentally, for a period of 18 months:

- (i) prohibit any vehicle from proceeding along Lake Street, Ferndale in any direction other than in a north-westerly direction between its junctions with Cross Lake Street and the Strand,
- (ii) prohibit any vehicle from proceeding along Lake Street, Ferndale in any direction other than in a south-easterly direction between its junctions with Cross Lake Street and Brook Street,
- (iii) prohibit the waiting of vehicles at any time on the lengths of roads and sides of lengths of roads specified in the Schedule to this notice.

Exemptions are provided in the Order to enable Medical Practitioners and Veterinary Surgeons to visit while "on call" and for the purposes of boarding, alighting, loading and unloading, building and road works, the maintenance, improvement, reconstruction, inspection or survey of the lengths of roads and sides of lengths of roads, the maintenance of essential services, weddings, funerals and the delivery or collection of postal packets by vehicles in the service of the Post Office. Disabled persons' vehicles displaying the relevant disabled person's badge will be allowed to wait for up to 3 hours with return prohibited within 1 hour.

The Order shall be operative from 14th November 1994, and a copy thereof and a map showing the lengths of roads and sides of lengths of roads to which the Order relates together with a statement of reasons for the County Council making the Order may be inspected, at the offices of the Mid Glamorgan County Council, Cathays Park, Cardiff, during normal office hours.

The Mid Glamorgan County Council shall be considering in due course whether the provisions of the Order shall continue in force indefinitely. Objections to the proposal, together with the grounds on which they are made must be sent in writing to the undersigned within 6 months from 14th November 1994.

The County Secretary and Solicitor may provide for the suspension or modification of the Order or part thereof, while it is in force if it appears that it is essential in the interests of the expeditious, convenient and safe movement of traffic, or of the provision of suitable and adequate parking facilities on the highway, or for preserving or improving the amenities of the area through which any road affected by the Order runs.

Any person wishing to question the validity of the Order or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, you may

Mid Glamorgan County Council (Pontygwaith Bridge, Edwardsville, Treharris) (Prohibition of Driving) Order 1994

Notice is hereby given that on 7th November 1994, the Mid Glamorgan County Council made an Order under sections 1 and 2 of the Road Traffic Regulation Act 1984, the effect of which is to prohibit any person from causing any vehicle, except for pedal cycles, to be driven on Pontygwaith Bridge, Edwardsville, Treharris.
