Cropston Road, Welland, Peterborough

Those parts of Cropston Road, Welland, Peterborough, which are described below:

- (a) the southern end of the parking bay and footway between the properties known as 6 Ragdale Close and 17 Rotherby Grove measuring approximately 25 square metres on the western side of Cropston Road from the south-westerly corner of the highway for approximately 5 metres in a north-easterly direction and for approximately 5.5 metres in a north-westerly direction as shown coloured red on the plan;
- (b) the western footway to Cropston Road approximately 5.5 metres to the west of the eastern footway as it passes by the properties known as 22-26 (even) Ragdale Close measuring approximately 55 square metres being approximately 2 metres wide and running for approximately 27.5 metres in length being split into two sections, one 12.5 metres in length and L shaped and the second beginning approximately 6 metres to the south of the other and being 15 metres in length as shown coloured red on the plan;
- (c) the footway and carriageway on the western side of Cropston Road at the southern end of Cropston Road adjacent to 245-249 (odd) Redmile Walk measuring approximately 101 square metres and running in a north-south direction from a point 2.5 metres to the south of the boundary between 243 and 245 Redmile Walk and being approximately 5 metres wide to a point level with the boundary between 247 and 249 Redmile Walk and thereafter the footway being approximately 2 metres wide to a point 6 metres to the north-east of the junction of the footway with the footpath passing between 251 and 255 Redmile Walk as shown coloured red on the plan;
- (d) the footway and carriageway on the eastern side of Cropston Road at the southern end of Cropston Road adjacent to 259 and 261 Redmile Walk being approximately 104 square metres and running in a south-west direction from the southern edge of the junction with the hardstanding area between 261 Redmile Walk and 28 Ragdale Close to a point level with the southern boundary of 259 Redmile Walk being approximately 7 metres wide and then the footway only from there to the junction with Redmile Walk being approximately 2 metres wide as shown coloured red on the plan.
