*The Stopping-up of Highways (Bedwas Road, Caerphilly, Mid Glamorgan) Order 199*

The Secretary of State for Wales hereby gives notice that he proposes to make an Order under section 247 of the Town and Country Planning Act 1990 to authorise the stopping-up of the highway described in Schedule 1 to this notice.
