WILDLIFE AND COUNTRYSIDE ACT 1981

*Cumbria County Council (Hermitage Hill) Limestone Pavement
Order 1994*

Notice is hereby given that on 4th November 1994 Cumbria County Council acting under section 34 of the Wildlife and Countryside Act 1981 made the Cumbria County Council (Hermitage Hill) Limestone Pavement Order 1994 designating the land described in the Schedule to the Order and prohibiting the removal or disturbance of limestone on or in it.

The Order (which is set out in the Schedule to this notice) took effect when it was made and has been submitted to the Secretary of State for the Environment. The Order will cease to have effect nine months after it was made unless the Secretary of State previously gives notice that he has considered it and does not propose to amend or revoke it, or that he has amended or revoked it, or that the Authority has revoked it.

Representations about or objections to the Order may be made to the Secretary of State for the Environment, Room 908, Tollgate House, Houlton Street, Bristol BS2 9DJ, before 23rd December 1994.

Such representations or objections should be in writing and should state the title of the Order. In the case of objections, the grounds on which they are made should also be stated.

*Cumbria County Council (Hermitage Hill) Limestone Pavement
Order 1994*

Whereas the land described in the Schedule to this Order comprises a limestone pavement which has been notified to Cumbria County Council under section 34(1) of the Wildlife and Countryside Act 1981.

And whereas it appears to the Cumbria County Council that the character or appearance of the said land will be likely to be adversely affected by the removal of the limestone or its disturbance in any way whatever, that the Council ought to order as follows:

Now therefore in exercise of the powers conferred by section 34(2) of the said Act of 1981, Cumbria County Council hereby designates and prohibits the removal or disturbance of limestone on or in the land described in the Schedule to this Order and delineated by a thick black line on the map prepared in duplicate, sealed with the Common Seal of the said Cumbria County Council and marked "Map referred to in the Cumbria County Council (Hermitage Hill) Limestone Pavement Order 1994". One duplicate copy of the map is deposited in the offices of the Head of Legal Services, Cumbria County Council, The Courts, Carlisle and the other is deposited in the offices of the Secretary of State for the Environment.

This Order may be cited as the Cumbria County Council (Hermitage Hill) Limestone Pavement Order 1994.

SCHEDULE TO THE ORDER

The Order area lies to the east of the A5087 Ulverston-Barrow coast road approximately 1 kilometre south-east of Ulverston, just to the north of Conishead Priory. The site is within an area defined as a County Landscape.

Hermitage Hill is a significant landscape feature rising as a low hill above the coastal plain and intertidal areas of Morecambe Bay. A Limestone Pavement Order was made at nearby Bardsea Park in 1990.

Limestone outcrops on the western slope of the hill as small scars, visible from the road, but the pavements are entirely within an area of broadleaved woodland and outcrop as bands of moss covered and scattered clints on the north-eastern slope of the hill. The pavements are not visible from any public rights of way but parts may easily be seen from the private driveway leading to the Priory from the north.

The woodland around the pavements has a canopy of oak, sycamore, ash, beech, wych elm and some yew. A scattered understorey is composed of hazel, elder, hawthorn and (rarely) holly. Ground flora of the pavements is dominated by mosses, however, the grikes and surface solution features also contain many typical woodland species, including dogs mercury, bluebells, red campion, hedge woundwort etc. The remainder of the wood has blackberry, raspberry and an abundance of ramsoms (wild garlic) and nettles. Ferns are also present in the deeper grikes and at the base of small scars.

The pavement outcrops appear to be largely undisturbed although the scattered nature of the clints towards the top of the hill suggest that some pavement may have been removed in the past.

Full details of the landscape, flora, fauna, geology and physiography of the site can be found in the notification, a copy of which is available on request.
