

notice that by virtue of the powers contained in the Customs and Excise Acts, certain goods, namely 567 cases of Miller draft, 832 cases of Zeus beer, 1,664 cases of Cruze beer, 100 cases Asti Spumanti Martini, 165 cases of Lambrusco, 1664 cases of Damburger Pils and 1,344 cases of Zeus beer have been seized as liable to forfeiture by force of the following provisions, namely:

- (i) *Section 49(1)(a)(i) and (iv) of the Customs and Excise Management Act 1979* as to the said goods in that they were imported goods, being goods chargeable on their importation with Customs or Excise duty and without payment of that duty, the said goods were unshipped in a port and removed from their place of importation or from any approved wharf, examination station or transit shed.
- (ii) *Section 170(6) of the Customs and Excise Management Act 1979* as to the said goods in that, the owner, having knowingly acquired possession of the goods which are chargeable with a duty which has not been paid, with intent to evade the said restriction with respect to the goods, is guilty of an offence under this section and the goods in respect of which the offence was committed are therefore liable to forfeiture.

Pursuant to the powers conferred upon them by sections 93, 100G, 100H and 127A of the Act, sections 1 and 2 of the Finance (No. 2) Act 1992, and all other powers enabling them in that behalf, the Commissioners made Regulations, cited as the Excise Goods (Holding, Movement, Warehousing and REDS) Regulations 1992. The Commissioners hereby give notice that certain of the goods referred to at the first paragraph hereof, namely the 832 cases Zeus beer, 1,664 cases of Cruze beer, 100 cases of Asti Spumanti Martini, 165 cases of Lambrusco, the 1,664 cases of Damburger Pils and the 1,344 cases of Zeus Pils, being Community excise goods, have also been seized as liable to forfeiture by force of the following provisions:

- (iii) *Regulations 6, 16 and Part IV of the Excise Goods (Holding, Movement, Warehousing and REDS) Regulations 1992 SI no. 3135* which provide that excise goods, in respect of which duty has not been paid, shall be liable to forfeiture where a breach of Regulation 6 or of any Regulation contained in Part IV of these Regulations, or of any condition or restriction imposed by or under such a Regulation, relates to those excise goods. The breaches alleged in respect of the said goods are:

- A. In the absence of any "duty deferment arrangement", the duty was not paid on or before an excise duty point.
- B. The owner was not a "REDS", as defined in the Regulations, not had he arranged for a "REDS" to account for the duty, nor were the goods consigned to a tax warehouse, approved in relation to goods of that class or description, nor was he, in relation to the goods, an occasional importer, who had complied with Regulation 15.
- C. The said goods were not deposited and kept under duty suspension arrangements only in a tax warehouse.
- D. The said goods were not, subject to Regulations 10 and 11, being moved in duty suspension from the place of importation to a Customs approved tax warehouse or any other premises under the instructions of a "REDS" who has complied with Regulation 12 or to an occasional importer who has complied with Regulation 15.

If you claim that the said goods are not liable to forfeiture you must, within one month from the date of this notice of seizure give notice of your claim in writing in accordance with paragraphs 3 and 4 of Schedule 3 to the Act.

If you are outside the United Kingdom and the Isle of Man, you must also give the name and address of a solicitor in the United Kingdom who is authorised to accept service and act on your behalf.

If you do not give notice of claim within the said period of one month or, if any requirement of the above-mentioned paragraph 4 is not complied with, the goods in question will be deemed to have been duly condemned as forfeited.

If you do give notice in the proper form, the Commissioners will take legal proceedings for the condemnation of the said goods.
