The City of Norwich (Off-street Parking Places) (Amendment No. 1) Order 1995

Notice is hereby given that Norwich City Council, in exercise of its powers under sections 32 and 35 of the Road Traffic Regulation Act 1984, and the Local Government Act 1972, propose to invoke the above-mentioned Order, the effect of which will be to amend the City of Norwich (Off-street Parking Places) Order 1990.

The effect of the Order will be as follows:

(a) *Chantry, Monastery and City Hall Car Parks*

To increase the Car Park fees and charges for the above car parks;

Up to one hour	60p
Up to two hours	£1-20
Up to three hours	£1-80
Up to four hours	£2-50
Up to five hours	£3-00
Up to six hours	£3-50
Over six hours	£8-00
Entry after 1900 hours	60p
Sundays	60p
Motorcycles	Free of charge

(b) *Evening Car Parking Charge*

The Tariff for all City Council Pay and Display Car Parks shall apply from 1900 hours;

(c) *Riverside and Gas Hill Car Parks*

Charges for lorry and coach parking at the above Car Parks shall be increased from £1-50 to £2-50 per day;

(d) *Unicorn Yard and Oak Street Car Parks*

Long stay car parking charges (over 2 hours) for the above Car Parks shall be increased from £1-50 to £1-60 per day;

(e) *St. Augustines Baths Car Park*

To increase the Car Park fees and charges at the above Car Park as follows:

Up to one hour	20p
Up to two hours	40p
Over two hours	£1-50
After 1800 hours	Free of Charge
Sundays	20p

(f) *Excess Charge Notices*

A fee of £45 shall be payable on the issue of an Excess Charge Notice which will reduce to £30 if the Notice is paid within two weeks following the date of issue and to £10 if it is paid on the day of issue.

A copy of the draft Order which will be known as the "City of Norwich (Off-street Parking Places) (Amendment No. 1) Order 1995 may be inspected in Room 400, City Hall, during normal office hours. Telephone enquiries may be made to Norwich 212028/9 (direct dialling).

The above proposals require the approval of Norfolk County Council.

If you wish to object to the above proposals you should send your reasons to me in writing by no later than 6th December 1994.
