months from the coming into force of that Order, or if that Order is subsequently varied by another Order, six months from the date of that Order (whichever is latest), send a statement in writing giving the grounds on which it is made to the Chief Executive, Municipal Offices, North Quay, Weymouth.

If anyone wishes to question the validity of the Order, or any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act or of any Instrument made under it has not been complied with in relation to the Order, they may within 6 weeks of the date on which the Order was made apply to the High Court for the purpose.
