- (a) Special attention will be paid to planning applications for development of land in or adjacent to the conservation area and the Council may require such applications to be advertised.
- (b) Anyone wishing to cut down, lop or uproot a tree situated within the conservation area must give prior notice of his intention to the Council.
- (c) Anyone wishing to demolish a building or part of a building situated within the conservation area must obtain the consent of the Council.
- (d) The Council will have a duty to formulate and publish plans for preserving and enhancing the area.
- (e) Permitted development rights are more restricted and the display of advertisements and installations of telephone equipment are more strictly controlled.
- (f) Loans and grants under sections 77 to 80 of the Act may become payable.
