The Camden (Free Parking Places) (Disabled Persons) (No. 6) Order 1994

The Haringey (Waiting and Loading Restriction) (No.) (Amendment No.) Order 1994

Notice is hereby given that, the Council of the London Borough of Haringey proposes to make the above-mentioned Order under sections 6 and 124 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The general effect of the Order would be to amend the Haringey (Waiting and Loading Restriction) (Special Parking Area) (No. 1) Order 1994 so as to:

- (a) revoke the Haringey (Waiting and Loading Restriction) (No. 3) (Amendment No. 2) Order 1994.

The prohibitions referred to in the above paragraph do not apply in respect of anything done with the permission or at the direction of a Police Constable in uniform, or in certain circumstances, e.g. the picking up or setting down of passengers; the carrying out of statutory powers or duties; the taking in of petrol from roadside petrol stations; to licensed street traders etc. The usual exemption relating to vehicles displaying a disabled persons' "Orange Badge" does apply.
